

1. Payment Plans

- A. \$10.00 per player per game. Payment must be made in Pro Shop prior to game.
- B. \$120.00 per player for season including playoffs. Payment due before the season begins.
- C. \$1000.00 for a team, this includes regular season and playoffs. Payment due before the season begins.

2. Game Format

- A. A four minute warm up
- B. Three fifteen minute periods, run clock
- C. A two minute intermission between periods
- D. Teams will switch goals between periods
- E. Ties will be decided by a shoot out
 - Five on five
 - If still tied, one and one
 - The “clear the bench” rule is in effect
- F. Games will revert to a stopped clock in the last three minutes if the goal differential is within one goal. The clock will be allowed to run again if that differential becomes greater than one.
- G. The clock will also stop to post penalties on the scoreboard
- H. The clock will stop incase of an injury.
- I. Each team will be allowed one: 30-second time out.

3. Rules

- A. **You must be 18 years of age or older to play in the league!!!!**
- B. Registration forms must be filled out, completed, and registration fees must be paid before you are eligible to play.
- C. Two line pass rule is in effect
- D. Penalties will be three minutes during run clock, two during stopped
- E. Fighting: First offense is a game misconduct and a \$20.00 fine.
Second offense results in a game misconduct, \$20.00 fine, and suspension from the league. Once a player is suspended the team captains must vote them back in.
- F. Any off ice incidents on Planet Ice property and you will be prohibited from any future facility usage.
- G. All planet Ice’s rules and regulations apply to league participants and spectators.
- H. Rosters will be locked after the 4th game.
- I. Wear proper colors for your team
- J. A player must play in 4 or more regular season games to be eligible for playoffs
- K. A player must be on a teams roster to be eligible to play in any game

- L. Teams must have at least five skaters to start a game, four skaters and in penalty situations. Less will result in a forfeit. Icing rules apply.
- M. There will be a paper forfeiture if your team cannot field itself be the scheduled puck drop
